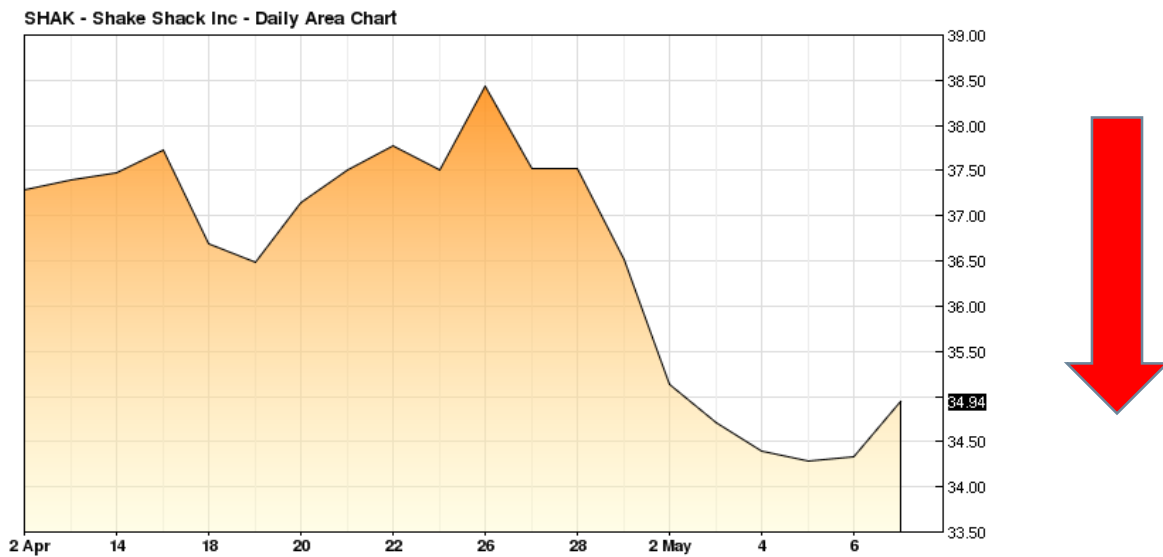
Shake Shack Inc. [SHAK] (AMC)

Scheduled for release May 12, 2016(after market close)

Shake Shack Inc. will be posting its Q116 quarterly earnings results. SHAK is expected to post earnings of \$0.05 per share and revenue of \$52 million for the quarter. In the last quarter the company reported \$0.08 earnings per share for the quarter beating the analysts' consensus estimate of \$0.07. SHAK is down 8.8% over the last month and up 0.8% over the last 3 months. The stock price is down 54.3% over the last year

 Consensus Estimates: \$0.07 (whisper) \$0.07 (estimize) \$0.06 (wall street)

StockJumpers trajectory analysis – reveals a negative reaction to the release though results are mixed. They may print positive numbers with increasing revenues, but will have trouble meeting aggressive expectations going forward. We are short for the event.
