
Scheduled for release March 16, 2016 (after market close)

Guess? Inc. will be posting its Q416 quarterly earnings results. GES is expected to post earnings of \$0.58 per share and revenue of \$654 million for the quarter. In the last quarter, company reported \$0.15 earnings per share for the quarter, beating analysts' consensus estimate of \$0.11. GES is up 27.5% over the last month and up 13.8% over the last 3 months. The stock price is up 30.1% over the last year.
