SATZ, State Attorney for the Seventeenth Judicial Circuit of Florida as Prosecuting Attorney for the State of Florida, in the County of Broward, by and through his undersigned Assistant State Attorney, charges that **ANTHONY WILLIAMS** on or about December 29, 2014, in the County and State aforesaid, did unlawfully practice law in Florida or hold himself out to the public as qualified to practice law in Florida, or did unlawfully and willfully pretend to be, or did willfully take or use any name, title, addition or description, to-wit: Common Law Counsel or Private Attorney General, implying that he is qualified, or recognized as qualified, to practice law in Florida without being licensed or authorized to do so, contrary to F.S. 454.23, (L1).

COUNT II.

COUNT IX.
FALSE OFFICIAL STATEMENT

FALSE OFFICIAL STATEMENT


