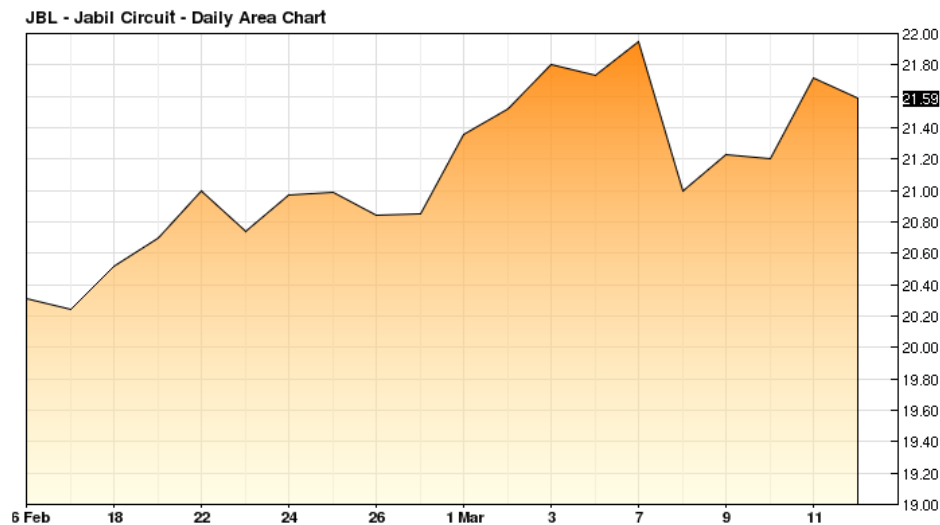
Scheduled for release March 16, 2016 (after market close)

Jabil Circuit Inc will be posting its Q216 quarterly earnings results. JBL is expected to post earnings of \$.60 per share and revenue of \$4,535 million for the quarter. In the last quarter, company reported \$.85 earnings per share for the quarter, beating analysts' consensus estimate of \$.82. JBL is up 16.6% over the last month and down 8.9% over the last 3 months. The stock price is up 1.1% over the last year.

Last 3 Quarters Jump Zone: -7.44%, 17.90%, -2.26%

Consensus Estimates: \$0.62 (whisper) \$0.61 (estimize) \$0.60(wall street)
