## Outerwall Inc. [OUTR] (AMC)

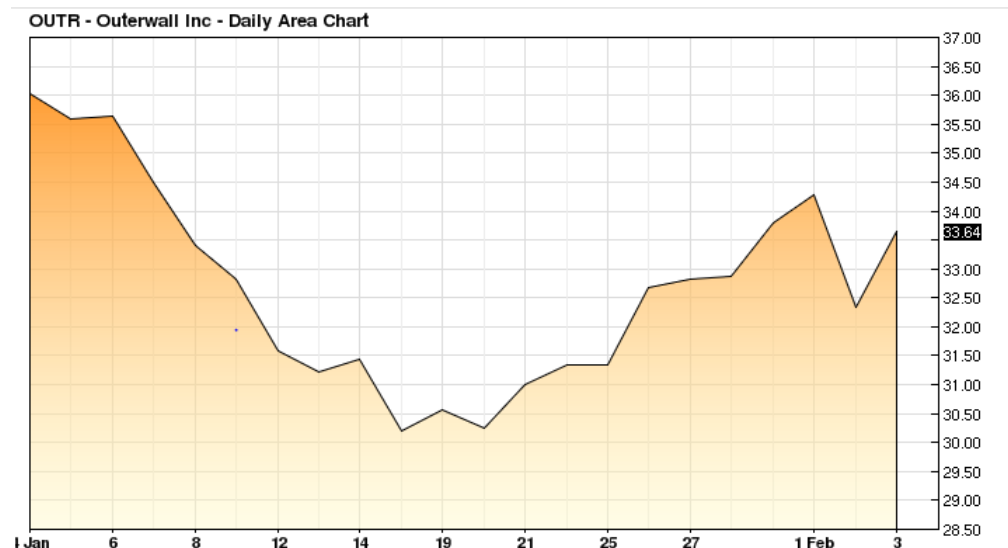
Scheduled for release February 4, 2016 (after market close)

Outerwall Inc. will be posting its Q416 quarterly earnings results. OUTR is expected to post earnings of \$0.64 per share and revenue of \$513 million for the quarter. In the last quarter, company reported \$2.21 earnings per share for the quarter, beating analysts' consensus estimate of \$1.63. OUTR is down 7.5% over the last month and down 43.7% over the last 3 months. The stock price is down 45.6% over the last year.
