Rackspace [RAX] (AMC)

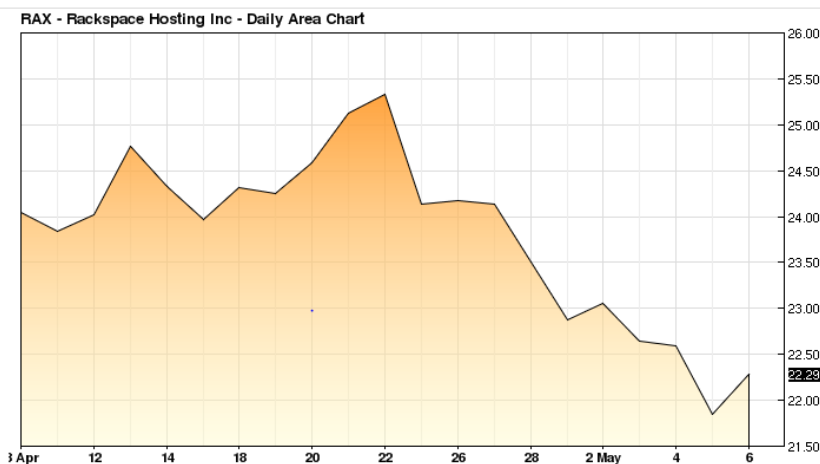
Scheduled for release May 9, 2016(after market close)

Rackspace will be posting its Q116 quarterly earnings results. RAX is expected to post earnings of \$0.22 per share and revenue of \$518 million for the quarter. In the last quarter the company reported \$0.24 earnings per share for the quarter beating the analysts' consensus estimate of \$0.23. RAX is up 5.9% over the last month and up 13.2% over the last 3 months. The stock price is down 57.6% over the last year.

Last 3 Quarters Jump Zone: -12.86%, 18.64%, -17.17%

Consensus Estimates: \$0.22 (whisper) \$0.23 (estimate) \$0.22 (wall street)
