To Whom it May Concern:
(cc. to Jean-Pierre Blackburn, the man acting as Minister of National Revenue)

Whereas CANADA REVENUE AGENCY (CRA) has reported credit for account# 7 [REDACTED]
of \$4,976.45 for the tax year 2007 on the August 2008 statement (copy attached), and,

Whereas the amount of \$4976.45 is not, has not, and has never been declared as tax, and,

Whereas the proceeds of the credit were provided by me, the creditor of the account, the living
man Paul Frederick of the Anderson family, and,

Whereas Section 337 of the Criminal Code of Canada states:

*Every one who, being or having been employed in the service of Her Majesty in right of
Canada or a province, or in the service of a municipality, and entrusted by virtue of that
employment with the receipt, custody, management or control of anything, refuses or fails to
deliver it to a person who is authorized to demand it and does demand it is guilty of an
indictable offence and liable to imprisonment for a term not exceeding fourteen years,*

I hereby demand that the credit balance on this account be returned to me, the rightful owner,
immediately in public funds. Please note that refusal to deliver it to me is a violation of CC s.
337 above and is an indictable offence, and that under the terms of CC s. 494(1) any one can
arrest anyone found committing an indictable offence.

Return of the funds shall be made within FOURTEEN DAYS of this writing or interest at 5%
per annum shall commence, in accordance with the rates posted on the CRA public website.
