Scheduled for release April 1, 2016 (before market open)

BlackBerry will be posting its Q416 quarterly earnings results. BBRY is expected to post earnings of \$-0.10 per share and revenue of \$559 million for the quarter. In the last quarter, company reported \$-0.03 earnings per share for the quarter, beating analysts' consensus estimate of \$-0.14. BBRY is up 3.4% over the last month and down 16.6% over the last 3 months. The stock price is down 20.3% over the last year.

Last 3 Quarters Jump Zone: -4.57%, -12.66%, 16.54%

Consensus Estimates: \$-0.03 (whisper) \$-0.05 (estimize) \$-0.10 (wall street)
