FACT: That the foundation of Commercial Law, being based on certain eternally just, valid, and moral precepts, has remained unchanged for at least six (6) millennia and forms the underpinnings of Western Civilization if not all Nations, Law, and Commerce in the world; is NON-JUDICIAL, and is prior and superior to, the basis of, and cannot be set aside or overruled by the laws and statutes of any Governments, Legislatures, Quasi-Governmental Agencies, Judges or courts. ## **EVENTS RELATED TO MY STATUS AS MAN**

- 6. FACT: On October 16, 23, 30, 2013 a Legal/Public Notice, Pronouncement of Non-Corporate Status was published. See Exhibit 2-C. This (a) clearly established My status as Living Man standing on the land, and; (b) rebutted all false presumptions about Me that formed the basis to prosecute Me, by incorrectly identifying Me as a person, corporation, U.S. citizen and vessel named WALTER BRUCE HARREL, known as the defendant, establishing that I'm none of these and; (c) Expressed My relationship to all trusts as the Beneficiary, NOT the trustee/fiduciary, surety or even the property or trust corpus; (d) Establishing My claim over My own name, mind, body and soul, re-claiming My Birthright that was stolen from Me due to fraud, deception & non-disclosure.
- 7. FACT: No rebuttals or counter claims have been received as evidence by Notary Public Notice of Default, Certificate of Non Response and Commercial Oath of Verification executed Nov 20, 2013. See Exhibit 2-C.

- 8. FACT: On November 26, 2013, **Notice of Appointment of Fiduciary** & **Notice of Status** & **Standing By Affidavit with Demand of walter bruce Family harrell** were filed with the clerk of the court RICHARD W. WIEKING. Certified copies were obtained and all of the above respondents were served by Public Defender Candis Mitchell. See *Exhibits 2-D, 2-E*. I, agent for the vessel was present during **the vessel's sentencing** hearing which does not constitute My agreement to contract with the court or accepting its benefits to be imprisoned in place of the vessel. I waive all benefits.
- 9. FACT: On December 4, 2013 a claim/lien was filed against the vessel in the official records of Pinal County Recorder Virginia Ross under File No. 2013-093429. See *Exhibit 2-C*. Attached to this was an *Affidavit of Appointment of Fiduciary* appointing back to the original fiduciary of the vessel.
- 10. FACT: On December 16, 2013 various United States agencies were served with the same above listed documents of My status via Registered Mail as evidenced by Proof of service by mail from Notary Public and USPS Certificate of mailing form PS Form 3877. All respondents failed to respond.
- 11. FACT: On January 6, 2013 **2**<sup>ND</sup> **Notice of Default, Certificate of Non-Response** was obtained by Notary. See *Exhibit 2-F*. This forever establishes the above affidavit as the **judgment in commerce**. All listed respondents failed to respond or rebut within a 35 day grace period which concluded on January 1, 2014. All respondents are now in default and without recourse.
- 12. FACT: On January 7, 2013 a UCC1 form was filed with CA Secretary of State under Filing # 14-7393937733, Document # 41038990004 as Filing Type: Transmitting Utility. See Exhibit 2-G.
- 13. FACT: Accompanied with this case affidavit, WALTER BRUCE HARREL vessel aka person of the defendant is herby submitted to the clerk of the Court in the form of a Certified copy of the vessel's Birth Certificate with a transparent overlay attached to the front showing Non-Negotiable Charge Back and 20 lines of text, 45 degree angle with Post Registered Account # RE 370 020 274 US. The back side is notarized, giving Notice of Appointment of New Fiduciary. All other respondents will be served with extracted copies via USPS Registered Mail. See Exhibit 2-B.

#### **CASE SPECIFICS AND REBUTTALS**

- 14. FACT: I am not a criminal. I have never committed a crime or injured anyone. This case has no injured parties and no victim have come forth to identify themselves. The U.S. Attorneys prosecuting this case lacks first-hand knowledge to all facts and all charges are denied. All charges were brought against the U.S. vessel, not Me, Living Man, never willingly consented to be the surety for the vessel.
- 15. FACT: All agreements with the court were signed under duress/constraint, *Vi Coactus* and I was tricked to sign as the surety; My signatures have been rescinded on all agreements with the court which is hereby null and void *ab initio*. I am no longer the fiduciary for the vessel. See *Exhibit 2-C*.
- 16. FACT: This U.S. court which resides in D.C, a political subdivision of the U.S. is foreign, acting under the Foreign Sovereign Immunities Act (FSIA) and does not have any jurisdiction over My body.
- 17. FACT: The UNITED STATES OF AMERICA, the plaintiff in this case is not a nation, but rather a Federal Corporation [28 USC § 3002 (15) (A)], a de facto government that does not represent "We The People". This corporation "state" has charged the alleged defendant, its own created vessel with fraud, while through its own hypocrisy are perpetuating a fraudulent scheme involving criminal acts of human trafficking, forced & involuntary servitude and organized criminal corruption, profiteering from an alleged victim-less crime, violating the Rule of Law. This is not justice, this is tyranny.
- 18. FACT: There is no evidence that this court is not engaged in the fraudulent administration of a secret constructive trust in the prosecution of this case. It was never disclosed who the grantor, trustee and beneficiary is and what property was conveyed. **Demand** is made for full disclosure as this will reveal a trust void of any property a violation of Trust Law.
- 19. FACT: There is no evidence that this court did not act without prejudice. Under threat of duress & coercion, in exchange of a lengthy prison sentence, I was pressured to take a **plea bargain** by accepting a false statement about Myself in order to get My consent as surety. This is **extortion**.
- 20. FACT: No signed written agreement with Candis Mitchell, Public Defender exist and none has been received after written request on 10/13/2013, but apparently she has been appointed by the court as an officer of the court who works for the state against the interest of the one she is to defend.
- 21. FACT: The court or its court appointed attorney Candis Mitchell never disclosed to Me that her role as a public defender is to act as a double agent in the best interest of the court and or the plaintiff, not the one she is allege to defend. According to Legal encyclopedia Corpus Juris Secundum on Attorney & Client Relationship [7 C.J.S § 4 "His <u>first duty</u> is <u>to the courts</u> and <u>the public</u>, <u>not to the clients</u>, and wherever the duties to his client conflict with those he owes as an officer of the court in the administration of justice, the former must yield to the latter." See Exhibit 2-H.
- 22. FACT: According to [7 C.J.S § 2], Clients are also called "wards of the court" in regard to their relationship with their attorneys. See Exhibit 2-H. This was never disclosed to me. These facts shows that there is not only a conflict of interest but a gross miscarriage of justice and malicious prosecution. I hereby terminate all court appointed client-attorney relationships.
- 23. FACT: When the court created a constructive trust forming the basis to prosecute the case, The law of Trusts clearly states that if the trustee and beneficiary becomes one and the same, the trust is automatically dissolved. The moment you brought Me in here to make Me the trustee of your constructive trust, you just dissolved the trust and you're operating in fraud, injuring the Living Man.





- 18. FACT: Any document that was ever signed in the affirmative Yes to "Are you a U.S citizen?" was signed by Living Man acting as an agent for another, the U.S Vessel, which is a corporate citizen of the United States, not Me, Living Man. In American law, the term 'citizen' relates to political rights or being a 'subject'. I am NOT a subject.
- 19. FACT: **My Pronouncement of Peace**: This affidavit is not intended to harass or intimidate. I come in peace with no intent to harm anyone.



If one appears before any court in the interest of another and moves the court to action with respect to any matter before it of a legal nature, such person appears as an "advocate", as that term is generally understood.15. The phrase "as an advocate in a representative ca-pacity," as used in the statute regulating the practice of law, implies a representation distinct from officer or other regular administrative corporate employee representation.17

In England and her colonies a "barrister" is a person entitled to practice as an advocate or counsel in the superior courts.14 A "solicitor" is a person whose business it is to be employed in the care and management of suits depending in courts of chancery.19 In the great majority of the states of the Union, where law and equity are both administered by the same court, it has naturally come about that the two offices of attorney at law and solicitor in chancery have practically been consolidated, although in the federal equity practice the term "solicitor" is in

general use; but in some states the office of solicitor in chancery is a distinct and separate office from that of attorney at law.20

A client is one who applies to a lawyer or counselor for advice and direction in a question of law, or commits his cause to his management in prosecuting a claim or defending against a suit in a court of justice;21 one who retains the attorney, is responsible to him for his fees, and to whom the attorney is responsible for the management of the suit;44 one who communicates facts to an attorney expecting professional advice,23 Clients are also called "wards of the court" in d regard to their relationship with their attorneys. -
