

[77598] AND FILE WITH THE CLERK OF THE COURT an answer to the complaint which is herewith served upon you, within twenty 20 days of service of this summons upon you, exclusive of the day of service. If you fail to do so, judgment by default will be taken against you for the relief demanded in the complaint.

default judgment is hereby entered and the injunctive relief sought in the counterclaim is awarded to Troy Lee. The Austin IRS Campus is ORDERED to

process a Treasury Refund check accordingly, for the amount of \$12,292.23. Jacob Joseph LEW and all agents are by law to forfeit seizure upon Troy Lee's property and person. If Jacob Joseph LEW and all agency fails to do so, a certificate of exigent circumstances will issue calling for Jacob Joseph LEW and all agent's arrest in the cognizance of the State Department and Speaker of the House. 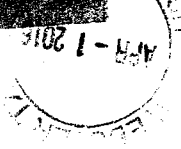
