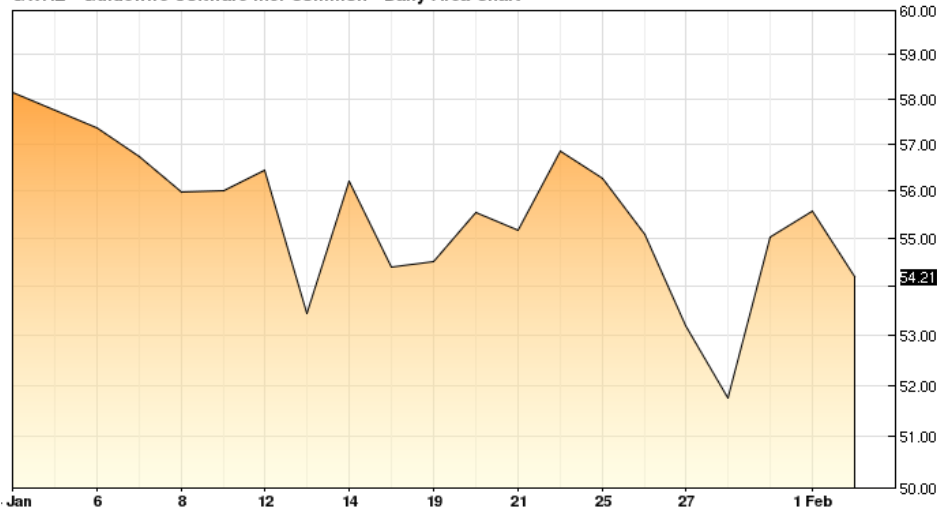
Scheduled for release March 1, 2016 (after market close)

Guidewire Software Inc. will be posting its Q216 quarterly earnings results. GWRE is expected to post earnings of \$0.15 per share and revenue of \$96 million for the quarter. In the last quarter, company reported \$0.07 earnings per share for the quarter, beating analysts' consensus estimate of \$0.03. GWRE is down 9.8% over the last month and down 16.9% over the last 3 months. The stock price is down 9.5% over the last year.
