JAIL, SHOULD NOT BE HELD IN CONTEMPT OF COURT FOR OBSTRUCTION OF JUSTICE,

IN SUPPORT OF PETITIONERS DEMAND, THE UNDISPUTED FACTS ARE:

1. ON DECEMBER 14, 2018 ATTORNEY DONALD L. SCHEHSE WAS APPOINTED BY THIS COURT  
TO PROVIDE COUNSEL FOR PETITIONER'S APPEAL OF CASE NO. 4:17-cr-3038  
FROM THE UNITED STATES DISTRICT COURT FOR THE DISTRICT OF NEBRASKA,
2. WHEREAS SAID APPOINTMENT REQUIRES COMMUNICATION IN ORDER TO PROVIDE  
EFFECTIVE ASSISTANCE OF COUNSEL, ATTORNEY SCHEHSE HAS REFUSED TO ACCEPT PETITIONERS  
PHONE CALLS SINCE HIS APPOINTMENT, THEREBY DENYING PETITIONERS RIGHT TO BE  
HEARD, RIGHT TO ADVANCE ALL DEFENSES AND RIGHT TO ACCESS THE COURT,
3. ON JANUARY 28, 2019 PETITIONER RECEIVED A LETTER FROM ATTORNEY SCHEHSE INDICATING  
HE IS FILING AN ANDERS BRIEF AND REQUESTING PERMISSION TO WITHDRAW  
FROM THIS MATTER. BY FAILING TO EXPLAIN WHAT AN ANDERS BRIEF IS, PETITIONER  
IS LEFT GUESSING WHAT ATTORNEY SCHEHSE IS UP TO AND AS SUCH, PETITIONER  
DOES NOT CONSENT TO HIS MYSTERY MOTION AT THIS TIME.

WHEREAS THE STAFF MEMBERS OF THE TIPON COUNTY CORRECTIONAL FACILITY HAVE ADVISED ME THEY WILL NOT PROVIDE ENVELOPES TO ME, I AM FORCED TO SEEK OUT THE KINDNESS OF OTHERS DETAINED HERE FOR ENVELOPES AND MY ACCESS TO COPY PAPER AND PEN IS LIMITED TO ACCEPTING THEM AT 2AM FOR AN HOUR OR TWO ONCE OR TWICE A WEEK. I ALSO HAVE LEARNED THEY ARE HOLDING MY MAIL FOR WEEKS BEFORE SENDING IT OUT OR DELIVERING IT TO ME.

THIS IS THE SAME TECHNIQUE USED BY WEST TENNESSEE DETENTH FACILITY IN MASON TENNESSEE THAT IS ALSO IN THE 25<sup>TH</sup> JUDICIAL DISTRICT, WHEREBY THEY DELAY OUTGOING LEGAL MAIL TO PREVENT TIMELY FILING AND THEREBY ASSURING THEIR PRIVATE FOR PROFIT CORPORATE PRISONS REMAIN FULL. THEY ARE DELIBERATELY ENGAGED IN OBSTRUCTION OF JUSTICE AS THESE ACTS FURTHER EXPOSE THEIR PATTERN OF ABUSES LISTED IN PETITIONER'S 1ST NOTICE OF OBSTRUCTION TO THIS COURT JANUARY 14, 2019, THEREFORE, PETITIONER DEMANDS A HEARING TO SHOW CAUSE WHY THOSE LISTED SHOULD NOT BE CHARGED AND HELD FOR OBSTRUCTION OF JUSTICE AND THAT PETITIONER SHOULD BE REMOVED OUT OF THE 25<sup>TH</sup> JUDICIAL DISTRICT TO THE FBI MILLINGTON TENNESSEE, THE CLOSEST ADJACENT DISTRICT.
