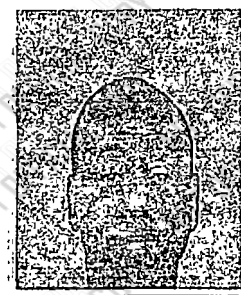

Probable Cause Affidavit

Before me this date personally appeared **BRACKE, KEVIN (16218)** who being first duly sworn deposes and says that on **16** day of **January**, (year) **2015** at **5100 S FLAMINGO RD, COOPER CITY, FL** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

The defendant did unlawfully resist and obstruct a law enforcement officer during the execution of his legal duties without offering or doing violence to his person. The defendant did unlawfully and knowingly remove an assigned Florida license plate from a motor vehicle and attach an unassigned fraudulent metal "Common Law Enforcement" plate to the rear of the vehicle. The metal plate is not on file with the Division of Motor Vehicles. Teletype revealed that the defendant had over three prior convictions for

Probable Cause Affidavit

Before me this date personally appeared BRACKE, KEVIN (16218) who being first duly sworn deposes and says that on 16 day of January, (year) 2015 at 5100 S FLAMINGO RD, COOPER CITY, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Driving While License Suspended in states other than Florida. The defendant does not have a valid Florida driver's license on file with DMV. This affiant observed the defendant fail to obey a clearly posted stop sign at 2500 blk Hiatus Rd.

To Wit: This affiant observed a silver colored Cadillac entering the Embassy Lakes Plaza from Hiatus Rd. The rear of the vehicle was bearing a "Common Law Enforcement" Foreign Diplomatic metal plate which was not on file in DMV. The vehicle was being driven by a black male and a white female front passenger. This affiant observed the vehicle exit onto Hiatus Rd and fail to obey a clearly posted stop sign and proceeded northbound. Based on the traffic related violations, a traffic stop was conducted at 5100 S. Flamingo Rd by a marked Broward Sheriffs Office police vehicle and this affiant. Contact was made with both occupants. The female was identified by her Florida driver's license as W/F Donna Hickenbottom 06/10/53. In addition, she produced a Florida registration form for the Cadillac which was registered to her. She advised that the driver removed the registered license plate from her vehicle and replaced it with another plate. The registered license plate is at her residence in Cooper City.

Deputy Neves requested the driver for a valid driver's license and vehicle registration. The driver produced a "Private Attorney General" identification card which included a digital photograph of the driver. The back of the ID Card had printed, "The Private Attorney General has SOVEREIGN IMMUNITY as Apostilled by the Secretary of State under Apostille No. 12-6799." A second time, Deputy Neves requested a valid driver's license and registration for the vehicle. The driver stated that he does not have a driver's license. At this time, the driver raised his driver's side window in an attempt to discontinue conversation with Deputy Neves and refused to exit

Before me this date personally appeared BRACKE, KEVIN (16218) who being first duly sworn deposes and says that on 16 day of January, (year) 2015 at 5100 S FLAMINGO RD, COOPER CITY, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

the vehicle per Deputy Neves' request. Based on the driver's actions, Deputy Neves opened the driver's side door and the driver exited the vehicle while holding a cellular phone toward Deputy Neves face. The driver was identified by his suspended Georgia driver's license as B/M Anthony Troy Williams 08/09/71. While standing outside the vehicle, Williams stated that he is not required to have a driver's license in Florida or any other state in order to drive. Williams stated that he placed the "Common Law Enforcement" plate onto the vehicle so that he can drive a vehicle in any state. Williams was arrested for Driving While License Suspended - Felony, Tag Not Assigned, Ran Stop Sign and Obstruct Officer. Donna Hickenbottom removed her vehicle from the scene. Williams was transported to the BSO Cooper City district office for processing. Williams was later taken to the BSO main jail for holding.
