GameStop Corp [GME] (AMC)

Scheduled for release March 24, 2016 (after market close)

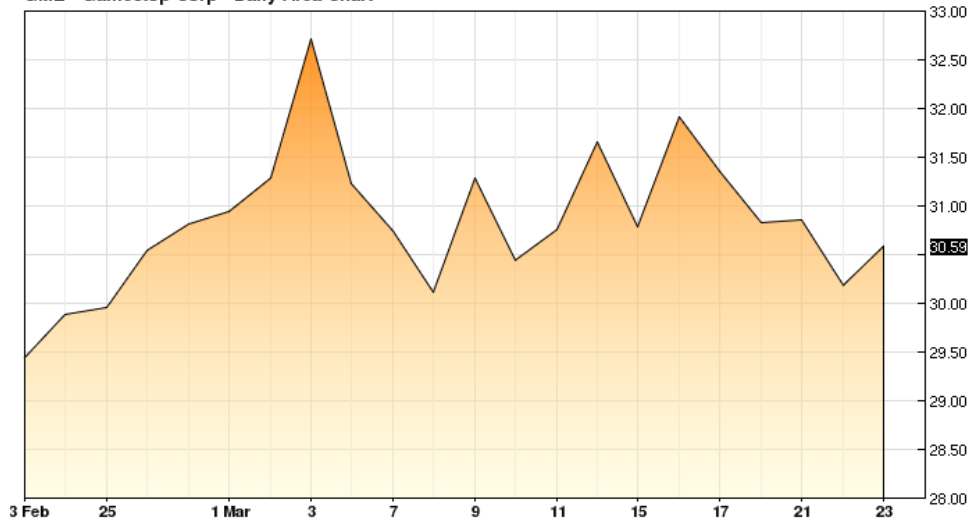
GameStop Corp will be posting its Q416 quarterly earnings results. GME is expected to post earnings of \$2.25 per share and revenue of \$3,567 million for the quarter. In the last quarter, company reported \$0.54 earnings per share for the quarter, failing to meet analysts' consensus estimate of \$0.59. GME is up 5.4% over the last month and up 7.2% over the last 3 months. The stock price is down 25% over the last year.

Last 3 Quarters Jump Zone: 8.72%, -10.09%, 1.65%

Consensus Estimates: \$2.27 (whisper) \$2.26 (estimize) \$2.25 (wall street)

StockJumpers trajectory analysis – reveals better numbers this quarter (though expected – profits from Christmas sales) with a bounce up post release. We are long for the event though the concern will be forward guidance and how they position sales going forward. Use caution.
